### January 2024 – MONTHLY MEMBER MEEETING MINUTES

President **Jackie Bryson** called the meeting to order at 6:00pm and welcomed our new members.

### **Monthly reports:**

Captain **Adam Hennie**, Cincinnati Police Department, reported the largest issue in the Downtown area continues to be groups of juveniles breaking into cars looking for drugs or firearms. Cameras have been added in garages to help address the issue. Secondly, a police Sergeant has been added to the area. Captain Hennie then addressed several member questions around gun control.

Officer **Chris Loreaux** - Cincinnati Police Department, reviewed the crime statistics noting, although it's early in the year, thefts from autos are up.

Lieutenant **Bob Von Hoene**, Cincinnati Fire Department, reported drug overdoses are up. A public health alert was issues on January 4<sup>th</sup> by local public health partners and the Hamilton County Addiction Response Coalition to enhance community awareness.

**Alex Martin** of 3CDC reported the winter shelter on Gest Street is open from 7PM – 6AM to single men and women experiencing homelessness. 3CDC is sponsoring a winter coat drive through February 28<sup>th</sup> for gently used but freshly laundered coats, jackets, hats, gloves, etc. Donations can be dropped off at 1203 Walnut Street or brought to the February DRC member meeting.

**Hannah Naberhaus,** Councilperson Cramerding Government Affairs Lead, proposed renaming a street in honor of Jerry Springer. The street location, which is TBD, would have an honorary plaque above the street sign if no objections from membership. No objections were voiced from members. The DRC Board will subsequently compose of letter of support.
